Info

The Nettailer order section will provide you with a list of orders that are ready to be handled. The order list contains useful and detailed information such as; order number, who placed the order and much more. Once you are ready to start to process your orders you will need to first of all click on an order to begin the process.

The Nettailer order section also provides you with a comprehensive filter system, should you wish to search for a different order status or filter orders by other means.

Order statuses

Status	What it means
All	Every order irrespective of what status it has.
Uncommitted	Orders where user didn't complete checkout.
Order received	Orders which have been received but are waiting to be processed.
Wait finance	Orders which are waiting for confirmation of payment.
Await bank	Orders which are waiting for confirmation of payment.
Payment denied	Orders that have been put together & payment attempted, but payment was unsuccessful.
Processing	Orders that are awaiting dispatch.
Partially dispatched	Orders where some lines have been dispatched, but others have not. This could also mean that some lines have not been fully dispatched (E.G. 5 hard disks ordered, but only 3 dispatched).
Dispatched	Orders which have been completely dispatched, but are not confirmed as delivered.

Delivered	Orders which have been delivered to the customer.
Cancelled	Orders which have been cancelled.

Order items

The orders section is the first page you will see from the admin section when you are logged in as a store administrator. To view your orders pending in the store you will first of all need to click on "orders". Once you have clicked onto an order you will be able to see all the items within the order and the customer content.

For those of you that use more than one distributor you can click on the online quantity in stock button which will provide you with information on which distributors sell the items within each order placed. This feature will allow you to make quick and informed business decisions on where to order items from as you will know if the items are in stock, the ETA date, the price and your margin.

The next step of the order process would be to use the drop down box next to each product line within the order and select a distributor to order the goods from. Once you have completed this process and providing you have a credit account with your integrated distributors you can now select "send online". This will send your order direct to the distributors you have selected for processing. If you do not have a credit account or the distributor does not provide an online XML version you will need to place the order manually and directly with the distributors.

If you have sent your order / orders by using the "send order online" functionality, Netailer will display a pop up box in the centre of your screen to confirm if you want to send the order. Once you have confirmed to send the Netailer system will show you a confirmation pop up box that the order has been sent to the distributors EDI system.

If you need to amend an order you can do this up before you send the order. You can select "log in as customer" and amend the order as if you were the customer. Once you have processed an order you can save changes by clicking "Save & Close" Once you have submitted the order at distributor level further information such as the "Order Number", "Distributor", "Tracking" etc will be stored on the Tab line and added to the order.

Throughout the order process the order status changes; Netailer will update the customer with the status of their order by email.

Running under the tabs at the top of the page are several red hypertext links which let you take various actions;

Feature	What it does
Printable order	This link will open a new window with all the order details, so if you need to print a complete copy for filing - use this.
Send order online	This link will send electronic purchase orders to the distributor/s.
Cancel order	This link will mark the order as cancelled. Details will still be stored by Netailer & can be seen in the back end, & also by the customer.

Edit Customer	This link gives you a direct link to modify any of the customer information (for example, the customer calls up after placing the order as they have entered an incorrect contact number).
Export	This link will export the order. This will only work if you have correctly set up an export for orders in Exports .
Log in as customer	This link gives you a quick easy way to log in as the customer.

If a product is not in stock, you can choose to order from a distributor and deliver to the client at a later date if the client accepts these terms, or you can cancel the current order line by logging in as a customer (see section log in as a customer)

Underneath each red link is a table of the lines you will see on the order.

Feature	What it does
Part number	Shows the part number of the item. Clicking the part number will show you the product details. On the product details screen, you can click 'Show product in store' to view the product information in your storefront.
Quantity	Shows how many of the products on the line have been ordered. If you need to change the quantity, you can do. Remember to click 'Apply' after you've modified the quantity, or it won't be saved.
In price	Shows the cost price of the product at the time it was ordered. This may not be the actual cost price available to you as it will be influenced by the 'In price Logic' that's been selected in Settings .
Price inc	Shows the price the customer paid per unit, including VAT.
Total inc	Shows the price the customer paid for the entire line (I.E. (Price inc) X (Quantity)) including VAT.
Price ex	Shows the price the customer paid per unit, excluding VAT.
Total ex	Shows the price the customer paid for the entire line (I.E. (Price inc) X (Quantity)) excluding VAT.
Margin	Shows the margin made on this line (I.E. ((Price ex) - (In price)) X (Quantity)). This is exclusive of VAT.
Status	Shows the status of the individual line.
Distributor	Let's you pick which distributor to order the product from. If the purchase order has already been sent to the distributor, this will show who the product was ordered from.

Is marked for return	Select if the customer wants to return the product.
Online quantity in stock	Click this to look for the most current distributor stock levels & prices. Always do this before picking the distributors & sending the order online.

Feature	What it does
Purchase orders	This tab shows all the purchase orders which have been created for the order lines. Click a PO to see the details.
Invoices	This tab shows all the invoices which have been created for the order. Click an invoice to see the details.
Returns	This tab shows all the RMAs which have been created for the order. Click an RMA to see the details.
Export logs	This tab shows all the individual exports for the order.

Order

Click on the Order to ensure you have the correct order information.

You can change the status of the entire order at any time which updates all the order lines and shows any comments from customers.

The comment field allows you to communicate with customers should you need to request further information or inform of a delay or any changes.

If you send an order directly from the system to a distributor, Nettailer will take care of the admin acknowledgement by sending all customers an email containing a "clickable link" to their orders. The customer can also view all this information once they have logged in under the resources tab.

Feature	What it does
Order number	Shows the Order number - this is unique to your store.
Internal Order Number	Shows the Internal Order number - this is a unique identifier for the entire Netset ecosystem.
External order number	Shows (and allows changes to) the External order number. This can be specified by the customer.
Send receipt	Allows you to send an order receipt to the customer.
Status	Shows (and allows changes to) the order status.
Do NOT send email to customer	Select this is the customer doesn't want (or if you don't want the customer to get) email updates throughout the order process.
IP Address	A permanent record of the customers IP address.

Order date	A permanent record of the time & date the order was placed.
Changed date	A record of the time & date of the last change made to the order.
Desired delivery date	The date the customer would like the goods delivered before.
Ordered by	Who placed the order.
Approved by	If the order went through an approval process, who approved it.
Sales person	The name of the account manager.
Total	Total value for all order lines & delivery, including VAT.
Total ex	Total value for all order lines & delivery, excluding VAT.
Currency	What currency the order was placed in.
Allow partial delivery	Whether the customer is willing to accept multiple partial deliveries, or not.
Register with the customer's contact information	
Invoiced	This will show if the order has been invoiced or not.

Customer info

Feature	What it does
Customer contact	The name of the customer.
Customer ref	If the customer has entered a customer reference for the order, it will show here.
Invoice reference	If the customer has entered an invoice reference for the order, it will show here.
Reference	If the customer has entered a general reference for the order, it will show here.
User	Displays the customer ID number.
Etailer-customer ID	The Etailer ID for the customer. This is unique within Netset.
Customer no.	The customers account number.
Is direct delivery	If the order is for white label delivery direct to the customer, this will be selected.

Comments

There may be occasions when you need to communicate with customers in reference to any changes or amendment from when the order was placed. Any comments entered into this field will be emailed to the customer & stored against the order and provide you with a time stamp.

Internal communication

Any comments entered into this field will be stored against the order for re-seller administrators only.

Terms

Feature	What it does
Goods label	Shows the name that the goods will be sent to.
Delivery option	Shows the delivery method that's been chosen.
Payment option	Shows the payment method that's been chosen.
Paid	Shows if the order has been paid for.

Packages

When a package has been shipped, you can enter the consignment number & select which courier it's been shipped with. This will email the customer with details & a tracking link.

Info

To set up a courier, go to [Shipping & delivery](#) > Carriers.

Tech Data order info

If the order is being sent from Techdata, this will show which delivery method has been used.

Contact info

This tab shows the contact information for the order and lets you makes changes if necessary.

Online order info

If the purchase order has been sent online to the distributor, the details are shown here, including the date & time stamp and who sent the PO.

Online Xml info

If the purchase order has been sent online to the distributor, this shows the entire XML log.

Create combined PO

Info

This is designed to reduce your shipping costs when fulfilling multiple orders from the same distributor. It allows you to order the goods to fulfill multiple orders & ship them to your warehouse for forwarding. It can also be used when you have multiple orders from the same customer.

Create purchase order

Once you have determined which order lines you wish to order you can then select an order line and click on "Create" You will need to specify where the products will be delivered and how they are delivered.

Feature	What it does
Deliver to	This will list the options available for delivery address. If you pick 'Store', the goods will be delivered to your address.
Reference no	If you want a reference number on the goods, enter it here.
Goods label	If you want to specify an additional label on the goods, enter it here.
Delivery	This will list the delivery options that the distributor offers. Select which method you want to use.
Send update emails to customer	Tick this box to email an order update to your customer.
Allow partial delivery	Tick This box to allow partial delivery.
Is direct delivery	Thick this box to indicate the order is to be shipped direct to customer.
Prio	Here you select the order lines to receive a reply first. This is to do with where each serial ends up when the distributor sends the information. It is possible to modify these priorities later if needed.

Invoices

This invoice feature will show you all the invoices created in Nettailer. If you wish to see view more content you can click on the invoice.

Under the heading "Invoices" its possilbe to create invoices for your customer. If you click on "Create" you can enter the due date and what you want to invoice. When you click "Save", this invoice is created as a PDF that is available through the customer's account and order. You can view the invoice by clicking on preview. If you want to mail it out, go to the invoice and click on "Send email". Please note that you need to have entered the information under Settings and PDF for the invoice to have your company information.

Purchase orders

Info



This feature will show you all the purchase orders created in Nettailer. If you wish to see more information, click on an order to view the details.

Uncompleted Orders

This section lists all the uncompleted orders that the store has recorded. This section often doesn't include a lot of information if a user hasn't logged in.

However if a user does login and adds items to the basket it can be recorded here and potentially used for upselling.

Returns



The return section lets you track RMA's & manage their status while communicating with the customer - very much like the ordering process.

Returns

The returns section will automatically show you new returns by default and the status is headed in a similar way to orders. You will be able to see information about the return date, Id, order number, invoice number, customer number and name. If you wish to view returns under a different status, you can select an option from the drop down menu and click "Filter"

Search

Status	What it means
All	All returns regardless of their status.
Order received	Returns requests received, but not yet processed.
Processing	Returns which are currently being processed.
Pending - Awaiting answer	Returns which are being processed. Waiting on a response from the customer, distributor or vendor.
Pending - Awaiting return	Returns which are being processed. Waiting for the goods to be delivered back.
Processed	Returns which have been fully processed.
Delivered	Returns which are complete
Cancelled	Returns which have been cancelled.

The return form contains more information about the return together with the customer's contact details. You can also see which product(s) were returned. Set the status of the return and write a comment such as who the customer should turn to or what the customer should do in the next step to complete the return. If there is an RMA number, you can fill it in by clicking on the product where the RMA number is available. When you click "OK" for the return, an e-mail is automatically sent to the customer. Each time you change the status or enter a comment, a new email is automatically sent to the customer.

Product

Products



The products section allows you to browse details of all products from your feeds and gives you the ability to create & modify custom products.

Search

Feature	What it does
Part number	Search for the exact part number.
Manufacturer	Search for products by a specific manufacturer.
SKU	Search for products with a specific Stock Keeping Unit.
Name	Find products with this search field in their name.
Price in	Find products with a specific cost price.
Etailer-id	The Etailer-id is globally unique in Nettailer & matches specific products to their CNET data. This should only return a single product.
Part of search words	Select this if you want to view any partial matches.
Type	This allows you to search only for products which have OPG prices.
Has CNET info	Find products with CNET information.
Categorized	Find products which have category & sub category information.
Distributor	Find products from a specific distributor.
Created after	Find products created after a specific date
Doubles	Find products which are available from multiple places.

Edit product

For products imported from supplier, the editing options are limited but there are some changes you can make. Find your product and click it to open up.

You then have two choices - **Edit** (Opens the product for editing) or **Show product in store** (Takes you directly to the product in your web store).

You can add product description and internal notes here. You can also upload more pictures, price and setting for whether the product should be free of shipping and more. If the product lacks a category, you also have the opportunity to categorize it.

At the bottom you will see these tabs;

Distributor extensions

The first tab on product level is "Distributor extensions". Here you will find the latest imported price data for the product. This function is useful when you need to know how the price have changed over a period of time or when you are looking for a faulty price.

Accessories

In the shop the accessories are listed under the tab "accessories" on the product card. click on "Connect product" and search for a product you want to connect and click on it. Generally, accessories are based on data from CNET and the connection will be done automatically. The product you add manually will be added to those added by CNET. You also have an option to add recommended accessories which will add them to the top of the list of accessories in a tab called recommended.

To remove a connection; click on the row you wish to remove and then "Delete".

Connected customers and customer groups


Here you can connect customers and/or customer groups to the product. If the product is connected to a customer or a customer group it will only be visible to those customers/customer groups.

Fields with an asterisk* are mandatory. Products cannot be created unless these fields contain data.

Active	If the product is active, it is visible in the store. Removing the tick box from here means you can work on a product without customers being able to see it.
Internal	Selecting this means that customers won't be able to see the product, but users with Admin or Seller rights will be able to.
Created date	Date stamp of when the product was created in the Netailer database.
Part number	The manufacturer's part number.
SKU	The SKU used to reference the product.
Name	The name of the product.
Name extension	Additional naming details.
EAN	The European Article Number (EAN) or Universal Part Code (UPC).
Price	The cost price of the product - excluding VAT.
Tax	Select if the product is VAT applicable or not.
Quantity in stock	How much stock you want the system to show.
Sorting	Set the sorting priority. Lower numbers attract a higher priority.
Description	The product description.
Spec	The spec for the product. Be Careful  If you want the specification to appear in a table, use the 'Spec' tab at the top of the page instead. See description below.
Distributor	Select which distributor the product is from. If you're creating your own product, select 'Netailer'.
Manufacturer	The name of the manufacturer.
Category	What category & sub-category the product belongs to.
Product Family	What product family the product should be grouped with.
Condition	Is the product new, refurbished or just plain 2nd hand.

Import

Feature	What it does
---------	--------------

Don't import product information	Enabling this will prevent Nettailer from using any CNET data, even if it exists.
Protect name at import	Enabling this will prevent Nettailer from overwriting the product name with CNET information.
Protect against removal by import	Enabling this will make it impossible to delete the product by entering a 'd' into the first column of a product import.

Image

Here you can add images to the product.

Function	What it does
File: Custom image	Upload the image you want as standard
File: Custom additional image	Upload more images.

Spec

The spec tab allows you to create the technical specification for a product in a table. "Just click Add & fill in the values".

You can choose to hide lines by deselecting 'Active'; however lines can also be sorted by adjusting the 'Sorting'. (Lower numbers will appear at the top of the list).

Supplier extensions

This lists all the suppliers that supply this product to your store.

Clicking on any of these lines will display the product log against the supplier selected.

Title	What it means
Etailer-ID	The ID Netset has given to the product for this supplier
Supplier	The supplier name
SKU	The SKU that this supplier uses internally to identify this product
Minimum pack quantity	Lists the minimum that quantity that can be purchased (only applicable to multi packs)
Supplier surcharge	Will display the surcharge set against this supplier (this value is set by store admin at System suppliers page).
Cost price	Displays your cost price on this product from the suppliers.
Qty	Shows the supplier stock available.

Use these feature to Add/View/Remove accessories to this product

Connected customers and customer groups

Use these feature to Add/View/Remove connections to specific Customers/Customer groups to this product

PDF

Used to Add/View/Remove documents to a product. These files may then be downloaded directly by the client from the Product pages in the store.

Bundles

Info

This section allows you to create complex products made up of multiple smaller products to offer to customers. (e.g.) You can create an entire PC system - complete with accessories & software.

Product packages are shown to the customer as a complete package or can be broken down into individual parts.

You can tailor an assortment of product packages that are shown to the customer as a complete product package and one price or broken down into individual parts.

A bundle can be a general product for all of you customers or connected to a single customer and/or customer group. A bundle will be visible under All products Your products Bundles.

Create/Edit Product Package

Feature	What it does
Active	Setting the product package as active means it will be visible in the store.
Name	Set the name of the product package.
Created date	Set the date stamp that will show on the product package.
Part number	Enter the SKU you want to give the package.
Price	Enter the price you wish to sell the product for (excluding VAT).
Total price	After connecting all the products & saving the package by clicking 'Apply', this will show the total cost of the goods in the package.
Split the package in the basket	Enabling this will break down the package in the customers basket, so they can see all the component parts.
Tax	Select the tax that the product package is applicable for.
Quantity in stock	Enter the amount of stock you want the store to show.
Check stock for included products	Enabling this will calculate how many packages can be created from the stock levels of the contained products & show that figure as the available stock.
Sorting	Lower numbers will appear higher in the product list.
Description	Enter the description that will show in the store.
Spec	Enter the specification that will show in the store.
Distributor	This must be set to Nettailer.
Manufacturer	Select the manufacturer you want the product to be labelled as.
Category	Select the category & sub-category that the product will appear in.
Image	Upload an image for the product.



When creating a product package, you won't be able to connect products until you've saved the package by clicking 'Apply'.

Connecting products

When you click 'Connect Products' you'll be taken to a page that lists every single product in your store. The first thing to do is use the Search field to find the exact product you want to add into the package.

When you've found the product you want - "click on it to add".

Connected product

Feature	What it does
Quantity	How many of this product are in the package.
Sorting	This affects the order that the contained products are shown in the product package description. Lower numbers will be higher up the list.
Clickable	If the product is flagged as click-able, the customer will be able to click the item description & see the product card.
Buyable	If the product is flagged as buy-able, the customer will be able to click through to the product card & add it individually to the basket.
Show price	This will show the standard sale price of the product in the product package description.
Part number	The individual product's part number.
Name	The individual product's name.

Connected customers and customer groups

If you want the product package to be visible for only a select number of customers, you can connect it to customers or customer groups here.

If the package is not connected to any customers or groups, it will be visible to all customers.

Focus assortments



Focus assortments allow you to promote specific products that are relevant for a particular customer or customer group.

Focus assortments is a feature designed to enable shop owners to create an assortment for individual customers and/or customer groups.

Normal use cases for creating a focus assortment are

- A deal with the customer containing a smaller amount of products.
- Guiding the customer to their most bought products
- Helping the customer find their OPG/BID products

You can create **two kinds** of focus assortments.

1. Focus assortments with your own categories
2. Focus assortments with the shops categories

Create/Edit Focus assortments (with the shops categories)

When creating a focus assortment using the shops own categories, all products are to be connected under the tab connected products. This can be done product by product or by using the excel import. Creating a focus assortment this way will show the assortment in the frontend with each product category.

Feature	What it does
Label	The name tag is the name which will be shown in admin when connecting the assortment to a customer and/or a customer group.
Label in front-end	This is the name of your customer will see in the shop.
For all customers	Selecting this will show the focus assortment to all customers that are logged in.
Show in category tree	Show in category tree is a legacy setting only used in none responsive design which would let you hide or show the assortment in the normal category tree.

Connect products to customer and customer groups

Search for the product you wish to connect to the focus assortment, now connect the customer or customer group.

To remove a product, select to product to be removed and click "Remove connection" at the top of the page.

Create/Edit Focus assortment with your own categories

To create a focus assortment with your own categories go to the tab "Agreement Categories". Here you create your own category tree, divided into main- and sub categories.

You can only connect your products to the sub categories. No products should be connected under the "Connected products" tab when doing a focus assortment this way.

When doing a focus assortment where you would like to place for example a printer and toners needed for it in the same category this is the way to create it.

Suppliers

The supplier section provides you with statistical information regarding the feed / feeds provided within your system. To view this information you can click "Statistics" to bring up the content table on how many suppliers are currently in the store, the stock levels, and categorised products containing CNET data.

You can click on "Statistics" if you want to see how many products each supplier sends to your Nettailer, if they are categorised, have CNET information and how many the supplier has in stock.

Supplier

Function	What it does
Label	The name of the supplier.
Export Id	The supplier's ID is of interest when communicating with other systems.
Weight type	Specify the type of weight used by the supplier. Net weight is exclusive of packaging, manuals, etc.
Product removal delay (days)	Give you the option to specify how many days a product may remain in the store if no longer in the upload.

Order email settings

Function	What it does
Customer number	Your customer number for the supplier.
E-mail, to	To which email address orders should be sent.
E-mail, from	From which email address orders should be sent.
Include product form data in order mail	Allows product form data to be included (if present) in order submission.
Use HTML email	Sends the order via HTML email
Xsl file	If not sent via HTML email orders will be submitted using this Xsl file structure (Netset's standard file structure is included by default, this tool does allow custom XSL to be uploaded)

Imports

Function	What it does
----------	--------------

Use headers	Check this if your import files uses headers. Checking this will skip importing the first row.
Use quote separator on text columns	If your import file wraps text columns in quote ("), check this option.
Import categories	The import will try to import categories when the last two columns are filled in with category codes.
Margin	Add a fixed percent to each product cost price before importing.

System suppliers

The system distributors section displays a list of all the currently integrated suppliers. It shows which are selected for use in your store and gives you information about the last feed you received from each supplier.

You may also get statistical information regarding the feed / feeds provided within you system. To view this information you can click “Statistics” to bring up the content table on how many distributors are currently in the store, the stock levels, and categorised products containing CNET data.

Import settings

There are some settings here that you may enter to help ensure that any errors from suppliers feeds are not imported into your store, preventing your stock or pricing to be incorrect.

Minimum number of products (% of previous import)	If import contain less than x% of products compared with previous import the import is skipped
Products with purchase price lower than limit skip below checks:	If product have purchase price lower than this value, below checks are skipped and is not included in the maximum limit

=> Maximum rejection % limit	If the number of products with 'error/low price' exceeds the specified limit the entire import will be rejected.
Minimum number of products from the supplier on a manufacturer before below checks:	The minimum number of products from a manufacturer within supplier file before the limits below will apply
=> Purchase price % difference before rejection on a manufacturer	During import, new and current purchase price are compared. If new price is less than x% of current it's considered as 'error/ low price'. Used in combination with setting below.
=> Maximum rejection % limit on a manufacturer	If the number of products with 'error/low price' on a manufacturer exceeds the specified limit the entire import will be rejected.
Purchase price change limit	If the new purchase price is lower than limit% of the current/last supplier price the product will not be update. For example 30% of last price 100, so price change <30 will be skipped.

Minimum prices

With minimum prices you can set rules for what the shop should do with products that cost below X during an import.

Manufacturers

Info

This section lists every manufacturer that is in Nettailer. Whilst you cannot edit the manufacturers which come from distributors feeds, you can create new manufacturers (such as your own brand to sell custom built PCs).

Create/Edit Manufacturer

Feature	What it does
External id	If you know the CNet ID, enter it here.
Active	Enable this if you want the manufacturer to be visible in your store.
Label	Enter the name of the manufacturer.
Home URL	Enter the manufacturer's website, if you know it.
Show in drop down	Enable this if you want the manufacturer to show in drop down menus.
Image	It's good to show the manufacturers logo. If they have one, upload the image here (.JPG, .PNG or .GIF are recommended).

Product range limitations



The product range limitations acts like a black-list - hiding certain products from all customers or selected customers or customer groups.

You can hide products, categories of products or entire manufacturer's by selecting them from the drop down selection box. You may wish to only hide products for a limited time, or only when customers are not logged in.

If you want to hide more products than you want to show, use the '[Product range](#)' instead.

Product range

Info

The product range acts like a white-list - hiding all but certain products from customers. If you want to show more products than you want to hide, use the '**product range limitation**' instead.

Product range allows you to show only specific products, categories of products or entire manufacturer's products in your store.

If there are specific customers you want to show certain products to, you can connect the range to customers or customer groups and even specify start and end dates.

Supplier import filters

Info

Import filters allows you to remove a specific manufacturer from a supplier during price file import. Inside each import filter you will then get a list of all SKU's that is filtered away.

Manufacturer	Enter the manufacturer that you want to exclude.
Distributor	Select the distributor which you want to remove the manufacturer from.

Warning

All changes are applied during the next distributor price file import.

Flags

In this part, you can set special conditions for the selected product range.

You have three different flags to choose from;

- **Buyable out of stock**
- **Freight free**
- **Buyable at zero price**
- **Hide product price for customers in basket and order history**

Note!



Activation of these flags applies to the entire store's range, for all users and can not be connected to specific customers.

Common to all these flags is that you select the current range, to which the setting should apply, with the following choices.

You start by selecting, **including**, a product range by selecting one of the following options;

Feature	What it does
Category	The setting applies to the selected main category or subcategory
Manufacturer	The setting applies to the selected Manufacturer
Category and Manufacturer	The setting applies to the selected main category or subcategory combined with selected Manufacturer
Product	The setting applies to a selected product

You can then combine the above range selection with **excluding** any subcategory, manufacturer or product.

Top sellers

Info 

The top sellers section is displayed on the left hand side of the store. This is based on orders that your customers have placed. You can choose how many are shown by changing the display quantity in Setting > settings> promotions and edit the free text boxes.

Create/Edit Top seller

Feature	What it does
Prio	This sets the priority of the item. Lower numbers will have a higher priority & therefore appear higher in the list.
Product	Enter the search criteria for the product & click search. You can then simply click the product you want, or refine your search criteria.


To remove a top seller from the list, simply click on it & then click 'Delete'.

Warehouses

Info

If you store your stock in multiple warehouses then you can reflect this in store. You can create warehouses and virtual warehouses and manage where the stock is situated. However should you not want warehouses visible to customers - stock levels can be merged by disabling Settings > Settings > Products > Stock > 'Separate stock per warehouse'.

Create/Edit Warehouses

Feature	What it does
Name	Give your warehouse a meaningful name
Sort order	This lets you dictate the order that the warehouses appear in your store. Lower numbers will appear higher in the list.
Supplier warehouse	Enabling this will show the stock levels from supplier feeds. Handy Hint  If you have multiple warehouses created - you should always have one warehouse set as your Supplier warehouse.

FTP stock import

Feature	What it does
Use automatic stock updates via FTP	If enabled you may update this warehouse via a file imported from an FTP specified in the following fields.
Host name	The URL/TTP address of the server you wish to access the file from.

Passive mode	The FTP can be run in Active or Passive mode, for this kind of setup passive mode is more commonly used.

Info 

Gross Product Weights let you accurately calculate the cost of [shipping](#) in [shipping matrices](#). This section lets you set products weights for products you have created or imported.

Product	Enter the product name or part number and click 'search'. You can then either select the product you want to modify, or refine your search.
Weight	Enter the weight in grams.

Product forms

BOLT-ON

This is a bolt-on feature and not part of the standard Nettailer.

A product form allows you to collect extra information regarding a product from a customer

Connected product

Connect your products by either searching for them one by one or by importing an excel using the excel import.

Connected customers and customer groups

If you want the product form to be visible for only a select number of customers, you can connect it to customers or customer groups here.

If the product form is not connected to any customers or groups, it will be visible to all customers.

Product Notification

If the notify me feature is switched on, this is the area that displays the list of "Notify Me" information. When a product is out of stock and the notify me button is pressed an entry of what that product is and who requested it is produced. Here you may manage those notifications. Giving you the option of supplying the product when its back in stock or offering the customer a comparison.

The "notify me" may be enabled via Settings->Products->"Disabled buy button"

These notifications will be deleted after 3 months automatically

CNet SKU

This feature allows you to check to see if a product has all the rich content provided by CNet. Including images descriptions and specifications.

All you have to do is enter the product information into the search boxes and click filter. If you product is included it will appear on a list at the top of the screen.

Configurators

Coming soon.

Expired products

Several parts of your store are affected when products expire or are removed by suppliers. Expired Products gives you a better overview and easy access to all affected elements (e.g. quotes, focus assortments etc). Each tab shows expired products for that specific element and the list is updated automatically.

Pro tip: Check Expired products regularly to catch changes early.

Shipping & delivery

Delivery options

In this section you will be able to add and change those deliveries you want to offer your customer in the check-out.

To create a new delivery you click on "Create".

For every delivery option you can add price, for which payment option it will be combined with and so on.

You can add which option that should be default for the customer on her/his customer card.

Note: There's a connection between delivery- and payment options.

Delivery options

Feature	What it does
Name	Add a name to the delivery option. This is what your customer will see in the check-out.
Code	Add an article number.
Customer connected	Tick this box if you want the delivery option will be exclusive for one or several customers.
Is direct delivery	If is ticked the order will be sent as default to the end customer as drop shipment. If it's not ticked, the administrators address will be used as default.

Allow

Choose which customer types that will be able to use this delivery option.

Payment options

Choose which payment options that will be able to choose with this delivery option. Don't forget to choose which one that should be default ticked for the customer.

Delivery sites

Manage cross-shipping further by adding cross-shipment addresses and connecting them to different administrator accounts, delivery options and even choose between drop and cross-shipment on order level.

Connecting delivery site to admin

Go to Customers & users/Administrator and click on the administrator account to which you would like to connect one of your pre-defined delivery sites.

Choose delivery site on order level

In the Contact info tab, uncheck *Is direct delivery* to open up all fields in *Cross-shipment address* section.

Connect delivery site to delivery option

When creating or editing a delivery option, go to the Cross-shipment tab and check the *Use cross-shipment address* checkbox.

Shipping matrices



The Shipping matrices offer a powerful & flexible way to manage how much your customers are charged for delivery.

Create/Edit a Shipping matrix

Feature	What it does
Label	Give your matrix a unique meaningful name.
Label in order	This is the label that the customer sees on their order & invoice.
Article number	If you export orders, this is the stock code that will be exported.
Customer specific	Select this if the matrix is for a specific customer or group of customers. Enabling this will show the customer selection information at the bottom of the page.
Base cost	This is the standard cost of the delivery.
Percent of order value cost	Set a percentage for the store to calculate shipping cost against the order value.

Be aware



As with every price in the back end of Netailer, the base cost should be entered without VAT.

Delivery

Feature	What it does
Delivery specific	If you want to give the end user multiple delivery choices (E.G. Next day, economy delivery, Saturday delivery, etc.,) select this box.
Delivery options	If the Matrix is delivery specific, pick which delivery or deliveries it applies to.

Geographical area

Area specific	Tick this box if you want this shipping matrix to be area specific
Countries List	Here you may select the countries you want to include in this shipping matrix (these first need to be created in the Countries section and then given properties in the Geographical areas section)

Weight

Use	If you want shipping to be calculated based on the weight of the goods in the basket, select this box.
Weight (g)	Enter the lower & upper weights (in grams) of the weight range.
Cost	Specify the additional cost that will be added to the base cost.

Distributor

Feature	What it does
Multiple distributor modifier - Add to	Adds a cost to the shipping matrix for orders that require stock from multiply suppliers. Will be applied once for every distributor after the first. This setting adds a specific amount per distributor
Multiple distributor modifier - Multiply with	Provides an exponential increase based on the number of distributors
Use distributor modifier	Tick to enable this feature, takes into account the values specified under Supplier settings
Multiply with the number of distributors	This may be used to disable the first options value from multiplying for every supplier attached to the order. Instead you can use the base value as an absolute amount if more than one supplier is used or you may specify the min or max amount of times to multiply the value by regardless of how many suppliers are used to fulfill an order.

The Min/max cost enables you to charge different costs of delivery depending on the cost of the goods in the basket in a similar fashion to [Price logics](#).

Category Settings

Info

Not every product from distributors has gross weight information available. Some distributors only supply us with the net weight of products (that is, the weight of the actual product without packaging & accessories). Some distributors don't give us any weight whatsoever! The Category Settings allow you to put a safety net in place when there's no weight information available.

If a product is available from more than one place (e.g. your warehouse and C2K), Netailer may well be given more than one weight. Netailer will also attempt to use the gross weight supplied by CNet, so it's important to decide which weight to use if there is a conflict.

Supplier priority for weight

Enter the priorities you want Netailer to use when calculating the weight of goods in the basket. Low numbers are a higher priority.

If a high priority source does not provide the weight, Netailer will automatically move to the highest priority source which has weight available.

Geographical areas

The Geographical area section is used to define more specific shipping properties for all the countries you choose to ship to from your store. Here you would create all the labels for countries you want to add more precise shipping costs to that you would later add in [Shipping matrices](#).

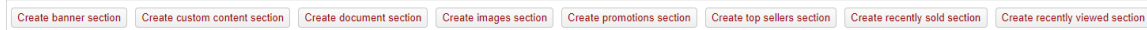

Category

Categories

In this section, you manually manage product categorization. In Nettare, it is not possible to edit or delete categories other than the categories you have created yourself.

The section manages the products into categories. Nettare is set up with basic categorization based on information provided by CNET with some refinement from Netset. Listed are the names of each main category. When a category is clicked on you can then see what specific products (or sub categories) are linked to that category. You can create your own category and link sub categories to it, however you can't edit or delete any of the pre-defined categories.

Categories or parts of categories with no associated products will not display in the store.

To add a category, click on "Create". Fill in the name, code and specify the sort order of the category with an integer. If no sort order is specified to a category it will be sorted by last name. The code should be two-digits and must consist of letters, A - Z.

Clicking the "Do not change the name" on imports prevents the imports from renaming the category. Finish by clicking on "Save & Close" or "Save".

Create/Edit Main Categories

Feature	What it does
Name	The name of the category. This is the one that can be seen out in the shop.
Code	Category code. The code should be two digits and must consist of letters, A-Z. Used mainly for imports and exports.
Do not change name in import	If you want to protect the category from changing when importing, you can activate this option.
Sorting	Specify the sort category to display. By default, it is alphabetical.
Show products below	If you want new products that fall into the category to be displayed immediately.
Hide in navigation	If you do not want the category to be displayed by default, you can enable this option.
Link this category	If you want something else to happen when the visitor clicks on the category, you can set it here. This link will appear in the category listing and on product cards for products related to this category. Please note that if you upload an image here, it will trump any category image.
Image	Note that if you upload an image here, it will trump any category image.

You must enter a category code when you create your own categories.

Create/Edit Subcategory

To create a subcategory, first click on the category under which the sub-category will be placed. All existing sub-categories are shown. Click on "Create". This displays a similar form as in the main category. Fill the rest of the form in the same way as for the main category. Finally, click on "Save". This category will be displayed under the selected main category.

Feature	What it does
Use long product labels	When creating products, you can specify both short and long product descriptions. Enable this if you want long product descriptions to be displayed by default.

Connected manufacturers

You can link manufacturers to each subcategory. Click on "Link manufacturers" and search for the manufacturer you want to upload. When you create new products, you can easily add which category the product should belong to.

Related products

It is possible to manually link related products at category level, but only on the categories that you have created yourself. Manually related products are then displayed under the tab "Accessories" in the Nettailer presentation section for customers together with other accessories. If you want to connect using excel, only a column with article number is required.

Promotions

Not in use.

You may now enter Meta information in to each category and sub category to help improve your SEO and drive your store to higher rankings with search engines. To add this information to your store, select a category or subcategory, edit it and under the "Meta" tab enter the information relevant to your business.

Category groups

This feature allows you to create groups in the category tree. This is useful if you want to work with comprehensive categorization for navigation. For example, "IT Products", "Environmental Products" and so on. The category group created is displayed instead of the category tree.

Create a new category group by choosing "Create". Give it a name, such as Audio & Visual. Then add the categories and/or sub-categories that you wish to be included in the category group.

It may take a few minutes to show your new category groups in store. To be sure you can see the results correctly. You can delete your cookies and restart your browser, or open your store in a different browser.

Accessories

To add an accessory you first select the product you want to make the accessory for, from the drop down boxes. Once selected you click apply and connect to it all the products you want to link it with. If you have an item in particular you want to highlight then you may use the recommended button. Once set up, these accessories will show up on the product page of the product you have them connected to.

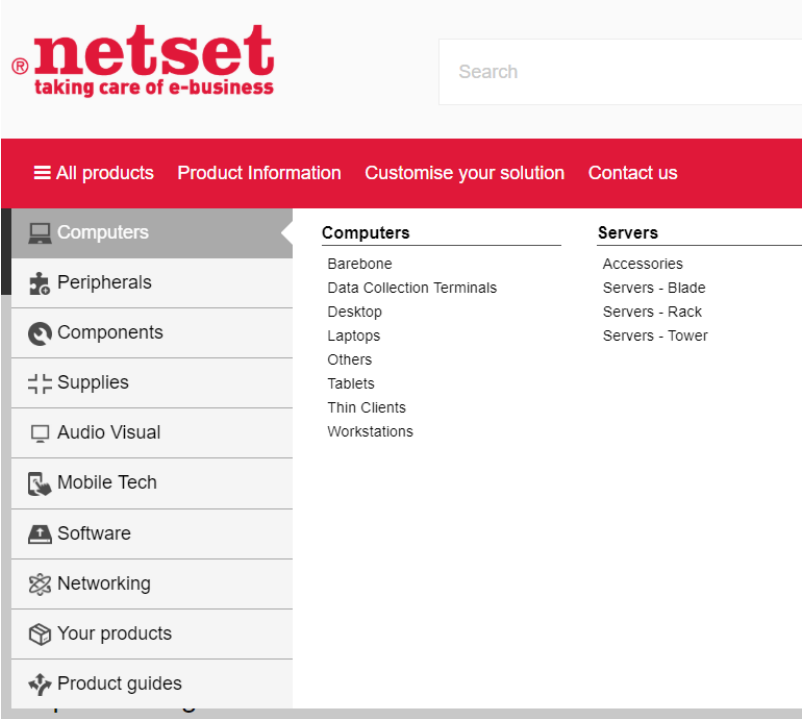
Category mappings

Online store category structure is based on CNet Channels structure. Netset have amended it to work more efficiently for market. Nettare tries to automatically map the distributor's catalog to the basic structure. Most products are mapped automatically but the remaining inventory that the store is supplied with, or that you can choose to add, must somehow be integrated with the existing structure. When products from external suppliers are added that are not managed by CNet Channel, Nettare will try to capture its category structure if it is able to be identified. It is then possible to relate this structure to the categories in the store.

Pricing

Price logics

Info

Price Logic's allow you to build some intelligence into the way your shop calculates prices. Want low cost cables to carry a higher margin than high cost laptops? No problem. Want to give your favourite customer preferential pricing? No problem.

General information about price logic

You specify per price logic what margins a certain selection or product should bear. The calculated output prices can be checked via the price test. It is possible to specify ten different margin levels (ten price lists) per price logic and you specify on the customer card which price list generally applies to the customer. The basic ten price lists, Price list 1 to 10, can be supplemented by customer or customer group specific price logic.

Nettailer comes with two general price logic's. One of these, called "*General*" cannot be edited or deleted. This price logic acts as a lifeline if you or someone else happens to remove your specific general price logic. Note that you must change the pre-filled values in the editable general price logic to the margins that are relevant in your case. If the general price logic is removed, or if the date has expired, the general price logic that cannot be removed will be used. The general price logic is used as a parachute to collect the products that do not fall within the scope of any other price logic.

The general price logic can be supplemented by a free number of price logic that specifies marginal levels at the manufacturer, category or product level. For example, you can create a price logic that provides a unique margin level for the manufacturer "*HP*". You can then refine the model with a new supplementary price logic with a different margin level for, for example, the category "*Computers / Laptops / Hewlett Packard*". If necessary, in the next step you can refine with price logic that gives the desired margin per product.

The general price logic can be supplemented with customer-specific price logic. These work together with the price list allocated to the customer on the customer card, for example "Price list 7". In practice, a price list is created for a particular customer in combination with a manufacturer, category or product. This makes it possible to give customer A an extra price list with, for example, a 7% margin on Apple's product range, instead of the 10% that would have been obtained according to the general price list.

Note

There are great opportunities to tailor and fine-tune the pricing logic structure. When you create your price logic structure, it is important that you think through which methodology is useful for your business. The basic idea is that you should be able to divide your customer base into different segments. For example, a certain similar customer segment is linked to "Price list 2" while another customer segment is linked to "Price list 7". The assigned price list should cover most scenarios for the customer, but can be supplemented with customer-specific price logic if necessary. The basic version offers ten different price lists for managing customer segments. Our assessment is that a normal retailer defines between twenty and forty general price logic's which are then supplemented with customer or customer group specific exceptions.

In this example, any product that costs £9.99 or less will be given a margin of 30% whereas any product that costs between £200 & £499.99 will have a margin of 15% applied.

Handy Hint



You should always have a default price logic to act as a safety net & ensure that every product is sold at a profit. With no default price logic, any product with no logic associated with it will be displayed as 'Call for price' in your store.

In this example, any HP branded Laptop will be given a margin of 10%.
Any HP product that is not a laptop will not be affected.
Any other brand of laptop will not be affected.

Price Logic Priorities

As the Price Logic structure is so flexible, it is possible to create overlapping logic's (for example, you could have one logic for Laptops & another for every HP product). To avoid any conflicts, we have put in place the following order of priorities.

Going from highest to lowest priority;

1. Customer specific price logic on the product (including fixed price logic)
2. Customer specific price logic on the subcategory
3. Customer specific price logic on the category
4. Customer specific price logic on the manufacturer
5. Default price logic on the product (including fixed price logic)
6. Default price logic on the subcategory
7. Default price logic on the category
8. Default price logic on the manufacturer
9. Default global price logic

Please note that a default or global fixed price will not override any customer or customer group specific price logic.

Here you set the administrator as active (if they are not, they cannot log on), set their username, their temporary password (the user will be prompted to change their password the first time they log on) & their role;

Role	Privileges
Administrator	Gives the user complete access to all settings, prices & features.
Seller	Gives the user the ability to log on as customers & place orders on their behalf.

Image

You can upload a small picture of the user which will be shown to their customers.

Security

Here you can specify allowed IP addresses for login.

Two-factor authentication

Two-factor authentication uniquely identifies a user using a combination of two different parts. In our case, the parts consist of username / password (something that the user knows) and a time-based code (which only the user can generate). This means that usernames and passwords themselves are not sufficient to log in and thus are offered extra security in case the login information falls into wrong hands.

Allow two-factor authentication - the administrator / seller is allowed to log in via two-factor authentication. In order to use this functionality, the user must be equipped with a client. Recommended clients for mobile phones are "Google Authenticator" or "Authy". To continue with this setting, go to "My profile"

Retailers

Info

This allows you to change fundamental properties of your site.

Retailer

Feature	What it does
Name	The name of your company/store.
CorpRegNo	Your corporate registration number.
Show retailer promotions only	Disabling this means you may inherit some global promotions from the Netailer root store.
Show retailer documents only	Disabling this means you may inherit some global documents from the Netailer root store.
Show retailer top sellers only	Disabling this means you may inherit some global top sellers from the Netailer root store.

Retailer specific homepage

This is where the URLs of your store are entered. If you add a new URL to your shop, enter it here after setting up your DNS. Do not enter http:// - but you can enter www. if you wish.

Warning

If you remove URLs from here, it is possible that you & your customer won't be able to access your store until Netset repair the settings, so be certain of the changes you make here.

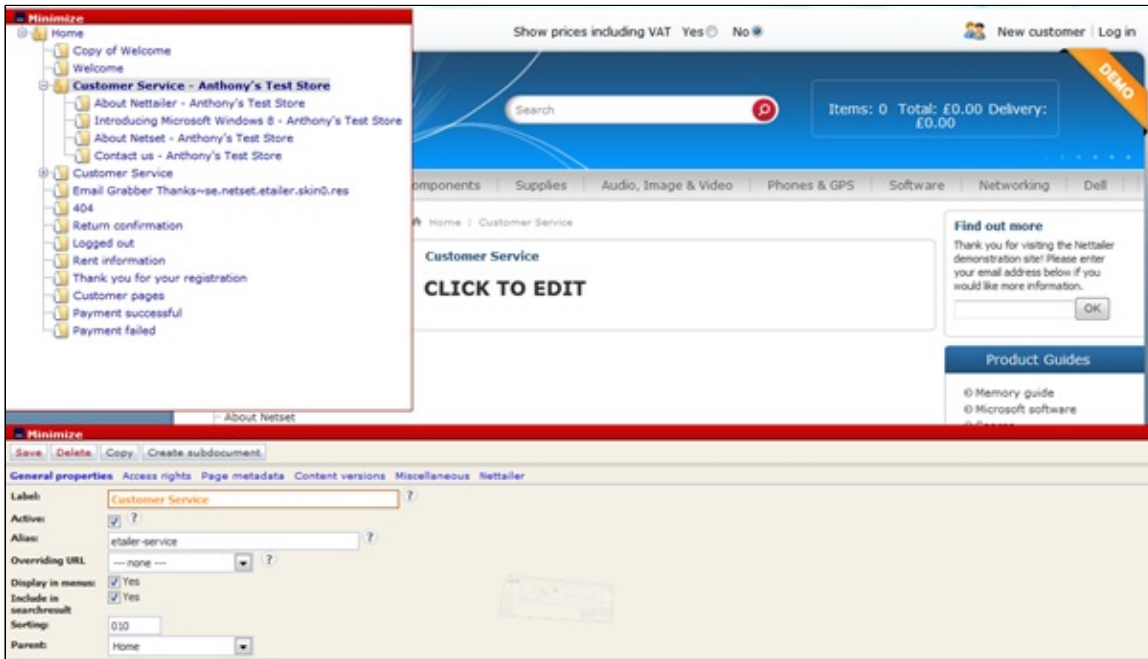
This is your contact information shown on your PDF quotes.

Documents & Pages

Documents

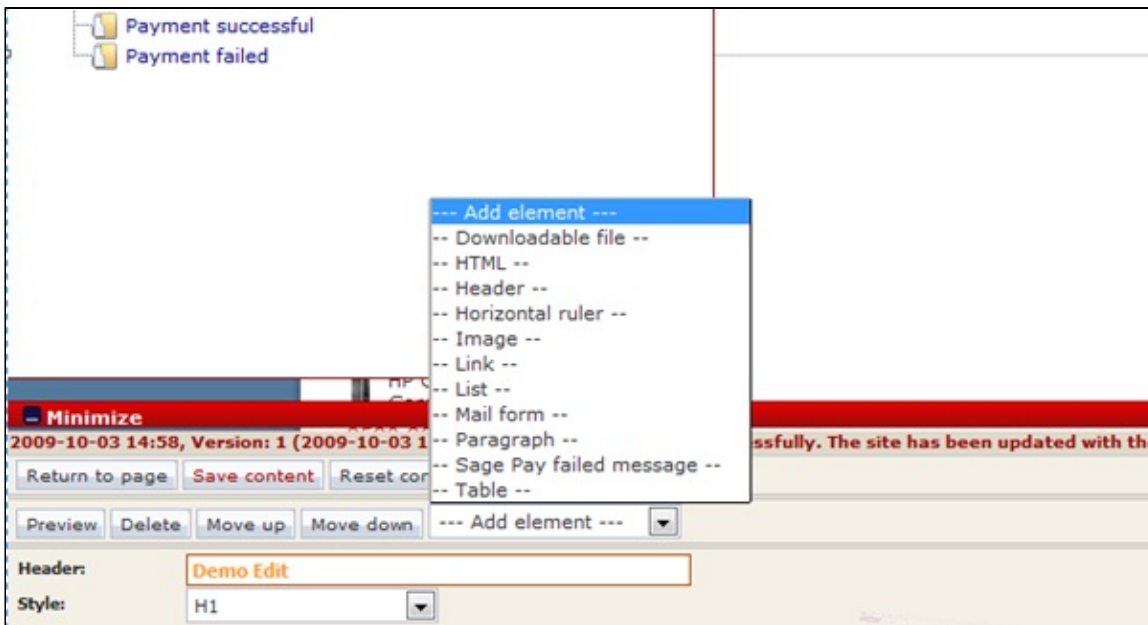
Nettailer contains a content management section. This is where your custom documents can be created. For example Customer Services, Contact Us and About Us pages etc.

Once this link is clicked a new browser window will open. This window is divided into three sections.



- 1, Top left is the navigation menu, where you can add or select an existing document to edit or view.
- 2, To the right is the preview window, giving you a look at your changes as you go along.
- 3, At the bottom of the screen is the editing section, this shows all the settings for the selected part of the document you are working on.

Once you have created a document or selected an existing document in the navigation window, you may start to edit it by clicking on the element in the preview window and putting the information into the editing section (bottom window).



To add content to a page, you will need to decide which element of content you want to add from the “elements” drop down menu. You can add a picture, paragraph, section, heading, link, download file and more...

Once you have selected the first element you are ready to add the content in the editing section.

Click on "Preview" if you want to check the results before then to save it. Click "Save content"

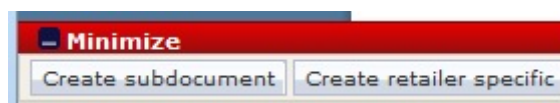
Warning



Please remember to press the “Save content” button once you have created pages or made any changes in the document section of Nettailer.

Customized pages

To create a customer or client specific welcome page, you will need to create a new sub-document by clicking the button at the bottom left of the page.




Then click on the template for “Public Documents”. This creates a new page to be edited. Click on the "click me" and enter a title in the "heading". For example, "Welcome to the customer name's Shop"

If you want to add a new element on a page, click on an element in the preview image and add new items via the "drop-down" menu called "Add element". Here you can easily choose whether you want to add a picture, paragraph, section, title, link, download file and more.

After adding a few elements to the page and entering your content into them, you will have created your own page that may be added to the resource menu, linked from another area of your site or connected directly to a customer or customer group.

Adding elements

Each element contains a set of options:

Element	Element Function
Image	You can upload any file in jpg, png or gif format. You can specify the required measure. If you only specify a value for height or width so the image is scaled proportionally automatically. You can also specify the image to be linked to URL or an email.
HTML	With this element you can paste or insert html code in to the editor manually.
Horizontal line	This element creates a line that you might need to use to mark the division of paragraphs or sections of the page.
List	This element allows you to create bullet or numbered lists. You can easily add lines and change the type.
Downloadable file	This element allows you to upload files to your customers to download, for example, a price list or invitation. You can choose whether the page should display a file type icon. This is done automatically and displays such as a PDF, Word or Excel icon depending on the type of file you uploaded.
Header	This element is used to generate headers. You can choose from six different styles for your Header.
Paragraph	<p>This element is used to create paragraphs of text or main content.</p> <p>Info  Any formatting on text you copy or paste from a word processing program will not be displayed.</p>
Table	This element, you can create simple tables. You can add and delete rows in the table by using the "+" - and "-" characters. You can specify whether you want the first row or column to be the Header / bold.
e-mail form	This element allows you to add the finished e-mail form you have created by Mail forms editor.

Mail forms

This is where you create a mail form for your customers to contact you through.

First click on "New E-mail form" This will open a new page displaying a few properties that need to be filled in.

Type in the name of this form in the label section and then enter the email address you want the mail to go to and the email subject.

Specify what the submit button will display, for

example "Send" or "Submit" and then specify the destination where the customer will end up after he has clicked on the link.

Next, you add the content of your forms from using Input fields or free text box. These are displayed on the left of your customer input box.

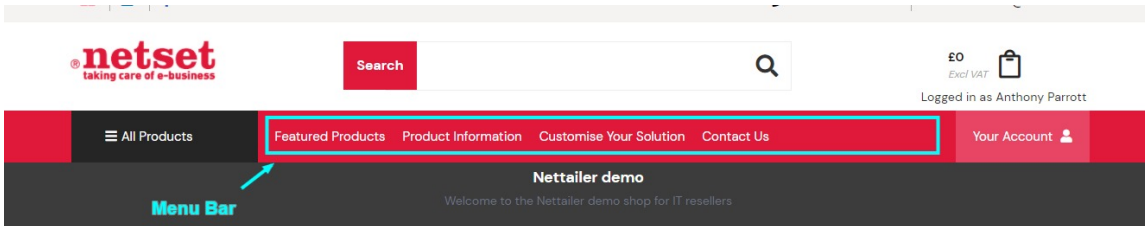

There are three types you can choose;

Feature	What it does
Text	This is used when you want a field to plain text. Can be used to allow your customer to enter phone numbers, names, email, etc. The number of columns determines the width and number of lines determines the height of the field that the customer can write in.
Select	Used to create drop down menu with per-determined choices, In values, type in the options to select. You separate the options with the return key.
Check box	Used to create a tick box.

You can then add this email form by going to Documents -> Documents. Select the page you want the form to be shown in. Then select "Add element" and then e-mail form. Browse to the form that you created and click "Save content".

Menus



In this part you have the opportunity to create menu links to internal document pages or directly to a URL.

If you do not want to link a document page directly to the menu, you can also create submenus here that you can link document pages to. That way, you can categorize these document pages.

Label	The name of your custom page. This is also used when locating the page to set it as a customer specific page.
Page type	Choose from predetermined pages which are linked to from different parts of the store or choose custom page to create your own.
URL	Give your page a unique URL in order to link to it. (useful if you want to link to the specific page from a picture)
Title	Used for metadata
Description	Used for metadata

Save page to access content.

Pages can be created for all your available languages by pressing edit page.
Edit a page as HTML if you wish to implement your own HTML code.

Financing

Financing allows the store to show monthly financing options. The customer gets a choice of your pre-determined options of financing at the checkout.

The settings are:

Setting	Setting Description
Allow for funding	This activates the financing function in the store.
View the details link at the checkout	This will show an information link at the checkout area leading to a document that describes the terms and conditions for the finance. You can create or edit this document in Admin / Documents.
Name	Enter the name of the service you want to use.
Item	Define the following article number that you want to use with this service. This is used if you integrate Nettailer to your business.
Break-point	Defining the break point you want to use for financing, for example £300. This will apply to individual products or the total sum of the basket.
Fiscal Periods	Define finance periods are in the store in terms of months and tariffs. You should also set the default period.

It is possible to disable the finance function of a particular customer or at the customer group level.

XML - Clicking on the red XML link will export all quotes as XML displayed on the page. If you click on the black XML link, you will only receive that quote in XML format.

Quote templates

BOLT-ON

This section is where you can add non product related additional content to your quotes.

Nettailer provides you with a coded template that allows you to drop your own information in, such as: Contact details, logo, terms and more...

Field	What It Does
Heading	This is the heading you want to appear as the start content after the addresses and logos. for example you may have a heading of "Your Quote"
Body 1, 2 & 3	These are the fields you enter your content into. Each of these fields act as separate paragraph, this is useful to display your content into a more manageable and readable format. These body fields all appear above any product information.
Footer 1 & 2	These fields are for any content you want to appear under the product information. For example your contact details or a disclaimer. Each of these fields act as separate paragraph.
Email Message	This field is for the message you want to appear on the email that the quote is attached to. This can be used for example to thank the customer for requesting the quote and telling them there is a quote attached.

Note



You can edit the template and add your branding, however you cannot adapt the layout as this is set to pull in CNet product content.

Quotes

BOLT-ON

You will only see this if you are subscribed to the "Quote tool" feature

Here you can view a list of all the quotes that have been made on the system. It is also where you may preview each quote in a PDF format or convert the quote into an order. You may also export all the quotes via XML using the red XML link at the top of the page or individually using the black XML link at the end of each entry.

Keep in mind that the "Show Quotation Requests in Cart" setting must be enabled.

Quote Requests

BOLT-ON

Here you can see all the quotes that have been requested in you store, when you first open this option you will have a table showing a list of the quote IDs, the customer name, address and the date the quote was requested on.

By clicking on a entry in this list you will then get all this information in more detail and all the products the customer has requested a quote on.

Email

Newsletter email

In this section, you create the basis of the email you want to send to your customers.

Setting	Setting Description
Start time	Specify the date and time you want the mailing to be sent. That way you can create a mailing schedule several days before it is sent.
Name	Enter a name for the mail. This information will not be sent to customers.
From	Fill in the e-mail address that will be the sender of the mail. Subject is the subject of the email that is sent, it is the title that appears as a message in the recipient's inbox or equivalent.
Subject	Enter the subject of the email that is sent, it is the title that appears as a message in the recipient's inbox or equivalent.
Template for newsletter	Select from the drop down menu a template you have previously created in the "Template for newsletters" section
Body	If you use a template then that content will show up here, if not then fill in the content you want to send. You can paste HTML code here to customize the look of the email.
Send as HTML	If you use HTML code, then this option must be selected. Otherwise the e-mail will be sent as plain text.
E mails	Here you can select the recipients of your mail. You can send it to a specific address, all customers or to a mail list that you have created in the "Mail lists" section

Mail lists

You can create a variety of lists to target a specific group of customers, for example customers from specific domain or buying group.

Create/Edit Mail lists

Feature	What it does
Name	Set a name for the list that you want to create.
Type	Then choose the type of list you want to create. <ul style="list-style-type: none">• From orders = Specify criteria for which, or which products, the customers should have purchased during a certain period of time. You can also make selections on Manufacturer, Category or Product, as well as From and To date. For example, it is possible to create an email list for those customers who purchased a Lenovo laptop between 2010-07-01 and 2010-12-31.• From Customer groups = The Customer Groups that you have created.• From Filters = Here you can create an email list based on a filter. All customers mail addresses who have this filter are included in the list.• Grabbed emails = A list on all emails grabbed from the email grabber feature.• Free text = Here you can create a list manually.
Manufacturer	If you have selected "From orders" above you can select the current manufacturer here.
Category	If you have selected "From orders" above you can select the current category here.
From Date	If you have selected "From orders" above you can select From which date here.
To Date	If you have selected "From orders" above you can select To which date here.
Create addresses	The shop then fetches the email addresses that meet the criteria and these are displayed in the Email addresses field at the bottom of the page.
Email addresses	You can review and edit the results here after clicking "Create Addresses".

Templates for newsletters

You can customise the email template to suit your company brand style. If you want to create a monthly newsletter you can use the E-template within Nettare. The template supports banner, two images, footer, products and offers. You can specify colors and add text where appropriate but please note you can not re code the template within Nettare.

Once you have created a template you can then connect products that will appear in the newsletter. You can also add offerings to the right hand side of the Newsletter template and add additional images and text. Providing all the products are in your Nettare site, when the customer clicks on a product from the newsletter, this can take them directly to the products on the site.

Whilst you are creating your template, you can check it by clicking on the "Preview" option or you can send a test to yourself by using the template you want to check.

The head section

The bulk part is built using the 'Banner', 'Banner Text', 'Products' and 'footer'. When you connect your selected products you can use either standard product or create your own information.
right

Note: Once you've created a template, you can make a copy of this to create future promotions should you wish to use the same banner, color scheme and titles.

Grabbed emails

Email Grabber is an optional marketing tool, allowing you to promote signing up for further information or your latest offers. This will appear in the top right hand side of the store below the menu. If you wish to activate this feature you can switch this on from > Settings > Settings > Miscellaneous.

HTML email

Here you will find settings for HTML email in general and also more specific parts such as order confirmations and product monitoring emails sent from the shop. You can customize captions, colors, fonts and add your logo.

General settings

These settings apply to all HTML emails sent from the shop.

Order confirmation

By default, order confirmation is sent out as regular text e-mail which you will find under e-mail templates and label "orderconf". When you enable this feature for HTML, by clicking in the active box, this over-triumphs the regular text email and this version of HTML email will be used instead.

You can preview your current settings by entering a relevant order number and your own email address at the bottom of the page. Then click on the "Send" button. If you do not use this function, the order confirmations will be sent to the customer in text format.

You can easily add additional terms under "Terms and Conditions - PDF" which is attached to the order confirmation.

Product notification

Here you can adjust the email sent to those who want a notification when a product is back in stock.

Email templates

There are a number of emails sent from the shop at various times or events such, as an order has moved from processing to dispatched. These allow you to edit by going into them and click on "Edit".

Warning!



It is important that you fill in the email templates before sending your store live. You will need to go through the "contact information" and specify on the templates the "from" email address for each mail template. This will ensure that your customers know who the email is from and they know where to respond if required.

The emails from the store can function without adaptations of additional content, however it's always advisable to add your own content, such as: "Thank you for shopping with your store name" to give a professional and personal touch.

Please do not remove any of the values seen in the templates, they are there for a reason and if removed will have consequences.

Imports

In this section you can import your own data or images to the shop. There are four different options and you can download the Excel templates, sample files and instructions for each type of import.

Product Imports

If you wish to extend the solution range of complementary products, there are procedures in place. Select the type of product imports. After that you can, via the option "Download template for Excel-import", download a zip file containing an Excel template that is based on a given product structure. The Zip file also contains an example and a description of the columns in the template.

Fill in the Excel template with the products you wish to replenish. The next step is to upload the Excel file.

Next use "Browse" to search and select your file. Once you find the file to be imported, click on the button "Execute the import."

Please note; You cannot make any structural changes in the Excel template, example. You cannot delete or add columns, however on some occasions you may not have to fill in all columns with data on the template. At the back of this manual is an appendix with field descriptions. Binding columns marked with an asterisk (*). You can find a detailed explanation of Import template at the end of this manual.

Fixed-price imports

This type of import is to be used in the event that you wish to administer fixed rates via Excel. This is useful in the event that you wish to work with a larger number of fixed prices. Imports constitute real price logics within the shop. If necessary you can edit imported fixed price logics using the same sheet.

OPG Imports

This import is used in the event that you wish to complete the shop with OPG pricing. This can be useful if for some reason you cannot obtain your "price file" with associated purchase prices automatically.

Customer Import

Here, you can import customers with associated information such as shipping and billing address. You can also add the price file and other additional connections that the customer needs to be associated with.

Warning



If you do not want an email to go out to newly registered customers once they have been uploaded please ensure that the "Registration Mail to new customers" is unchecked.

In this part you can also create your own dynamic template. At "**Dynamic field template**", click on Edit / Create and then select the fields you want to be in the template.

When you are done, click Ok and then select the template you created. Note that the columns in your excel file must have the same order as you created in your template.

Image Import

To import images in a coherent way you must make sure that the image is named the same as the manufacturer's part number, plus the file extension. (Jpg or Gif) Once you have collected the images you want to import into a folder, create a zip file of images in the folder.

Zip the file to the upload by selecting the type; "Photo Import" during the import, and then use the "Browse" button to locate the file to be imported. Click on "import". The pictures will be treated to images sized to best fit into the store.

Stock Imports

Import of own stock is done by imports. You can also choose which layer for the import if you have several warehouse locations.

Agreement assortment product import

Import products to an agreement assortment list. This can be very useful if you have a long list of products to add.

Function	What it does
----------	--------------

Save import	This option lets you configure a recurring import via FTP. When the file is updated on the FTP, it will be scheduled for import in the shop.
Type	Choose the format of your import file. These are the options available to use.
File	Pick a file to upload.
Focus assortments	Choose the focus assortment to import to.
Full file import	If checked, the current focus assortment will be emptied and replaced with the products in the import. Otherwise, the current products in the focus assortment will be merged with the products in the new import.

Export

Exports

Nettailer can export data in different ways. This can be useful for tasks such as creating feeds to price comparison sites, send a price list to a customer or export data for integration with other systems.

- You can choose to export to a file as a single export, or export to FTP.
- You can customise each export, this allows you to define the FTP settings, such as FTP addresses and ranges to export, "File Settings", "selections" and "Field".
- You can sort the order in which fields should be exported to the settings in the "Sort Order" field, such as 10, 20, 30 and so on. Nettailer export fields in ascending order.

Fields that have no value in the sort order when the default is zero, will not be exported.

The various exports, you can create are:

Export	Export Function
Customer delivery addresses	Used to export customer delivery addresses.
Customer invoice addresses	Used to export customer invoice addresses.
Customers	Used to Export customers from the site.
Distributor Prices	This is used to export the purchase prices.
Grabbed Emails	This exports the e-mail addresses which have been registered using the Email Grabber.
Main Category	Used to export categories and their category codes. This can be useful if you want to sync categories with other systems.
Manufacturer	This exports manufacturers and their codes. This can be useful if you want to synchronise with other manufacturers systems.
Orders	This is used to export financial system data. You can select the "from" and "to" date, and method.
Price List Export	This is used to export sales prices of all products in a price list.
Products	This allows you to export your product range in different ways. For example, you can include categorisation and prices.
Sub Category	The export sub categories and their codes by category. This can be useful if you want to sync sub-categories with other systems.

Single object exports

If you want to implement export of a customer or a purchase order, you can create them here. You can export via a web service (HTTP) or via FTP.

When you click "Create" you have two different kinds of exports to choose from:

Export	What it does
Orders	This is the export of customer orders. You can get this exported either when the order comes in, when you send the order to the distributor or if you want to manage exports manually.
Purchase Orders	This is the export of purchase orders. You can get this exported either when you send the order to the distributor or if you want to manage exports manually. Each product has its order number that goes hand in hand with the sales order.

Statistic

Login Statistics

This section displays statistics about the customers who have logged in to site, how many times and if there are any pending orders.

Active users

This facility shows all the active users currently in your store and a daily report on how many people logged in.

Sales Statistics

Provide you with all the information of the orders placed on your site. This can be filtered on; total orders, this month, last month, today and yesterday. You can also see all the order values.

Retailer statistics

This is where you can view information about your retailers by utilizing the filters to drill down through selected dates, including the number of registered customers, order values and products purchased.

Product statistics

This area is used to see the information on particular products you want to gather information on by drilling down through selected dates.

Customer group statistics

This area view shows the "Total sales this year" by customer group.

Terms

Payments

This function is used to manage the type of payments you allow your customers to use in your store, for example "PayPal", "credit card" or "invoice".

To add a new payment option simply click on "create" and enter in the details of the payment type you want to use. To delete an item click the entry you want to delete. Then click "Remove."

Feature	What it does
Language	(OPTION) - Specify whether the payment method should only be shown to customers using a specific language or all. This will only be visible if your store is setup with multiple languages
Name/label	Give the payment method a meaningful name.
Code	If orders are exported to external systems, this code is used.
Group	Here you associate the payment method with a group of payment methods. You first create the group under "Payment method groups".
Payment provider	If an external payment provider is to handle the transaction itself, this is stated here.
Payment type	As for "Payment type", this can normally be set to "General". In case you use credit card payments or on-line credit information, other payment types can be specified.
Sorting	Specifies the order in which the payment method should be displayed at checkout.
Logo (340x35 pixles)	Upload a logo on the payment option here.
Payment information	Here you can enter information about the payment method or write if it costs something extra.
View payment information instead of name and logo	Activate to view payment information instead of name and logo.

The default payment type is set to 'General'. You will need to create other payment options if you want to allow credit cards or other on-line methods of payment. These payment options can be connected to specific customers or customer groups, giving you a lot of control over how certain people can pay for their goods.

There is a facility to link payment types to specific delivery times. So for example you may wish your credit card customers to receive deliveries faster than your standard delivery time, you can just connect that payment type to a specific delivery time, from the options you have created under the "shipping" section.

Invoice

Feature	What it does
Create an invoice and send it by mail on a new order	Activate this if you want the payment method to automatically generate an invoice and send it to the customer via e-mail.
Set invoice as paid	This removes the last date to pay. Used in eg card payments.

Fees

Feature	What it does
Use fee	Activate this if you want it to automatically add a charge to the total order value.
Amount	Enter a Fixed Price or a percentage of the order value. You can also set the maximum amount and the minimum amount to be used if the percentage amount is specified.

Allow

Feature	What it does
Company	Activate this if you want companies to be able to use the payment method.
Private/Consumer	Activate this if you want consumers to be able to use the payment method.
Show only to administrators	Enable this if you want only administrators to see the payment option. Can be good at the time you order for yourself.

Delivery method

Activate the delivery methods for which the payment method should be active.

Order confirmation

Enter the page that will be presented as soon as the order is placed. Note that you first need to create the page under Documents.

Payment option groups

This section allows the creation of payment option groups. This is where you create a group that may later be connected to a payment type and then linked to a specific customer or customer group.

Feature	What it does
Name	Here you can name your payment group, for example "Financing".
Sorting	Specify the order in which the group is to be presented. The lower the number, the higher the group is presented.
Information on the left	If you wish to provide any information regarding all payment options in the group, you can do so here. The information is shown on the left side.
Information on the right	If you wish to provide any information regarding all payment options in the group, you can do so here. The information is shown to the right.
Logo	You can upload a logo that represents the payment options. We recommend that it is no more than 100px wide.

Example

For example, if you want create three payment groups; Card payment, Invoice and Financing then you create those here. Therafter you connect the alternatives that should be presented to respective payment method.

Taxes

The Tax rate for your store is set here, for example UK stores are set at 20% by default in the store. You are able to edit this value here.

Setting

Settings

Info

At the top of the Settings page are seven tabs. In these tabs, you can set a number of pre-sets that govern the way the store functions & presents information. Don't forget to click "OK" or "Apply" when you're finished, or your changes won't be saved. The button "Reset settings" at the top of each page will reset everything on that page back to the default values.

Products

Product list

Setting	What it does
Default "Sort by lowest price"	Modify the product filter to have "Sort by lowest price" enabled by default. This will sort the product list by price ascending.
Default "In stock"	Modify the product filter to have "In stock" enabled by default. This will only show products which are in stock in the product list.
Show store stock filter	Enables the ability to display only products that are in stock at your own warehouse/store. Can be set on category level. Requires you to use the function "Products" -> "Warehouses"
Default "Available in store"	Sorts products that are in their own warehouse by default at the top of the list.
Default "Show images"	Modify the product filter to have "Show images" enabled by default. This will show pictures of the products in the product list.
Default "Show part number"	Modify the product filter to have "Show part number" enabled by default. This will show part numbers in the product list.
Default "Show manufacturer"	Modify the product filter to have "Show manufacturer" enabled by default. This will show the manufacturers name in the product list.
Show additional text filtering in product list	Allows the user to search within the category they are in.
Search only among categorised products	This will effectively hide any products which are not categorised. Be aware - this will make them impossible to buy.
Show only products with CNET information	Shows only products that have CNET product information.
Show search result as promotions	When a customer searches for a product, the top three results will be shown as promotions above the product list. Disable this tick box & they won't be shown any more.
Allow to select the number of products per page	Allows the user to select how many products are displayed per page during search or category search. The number that the user can choose from is 5, 10, 25 and 50 per page.

Number of columns in product grid layout	Allows you to set the number of columns products are displayed in when the user selects the column view mode in for product lists.

Be aware



Modifying the defaults does not set them in stone. Values defaulted above (with the exception of "Search only among categorised products") can still be temporarily modified by anyone browsing your site.

Product families will not be shown if "Sort by lowest price" is enabled.

Product card

Setting	What it does
Enable internal notes	Enables a function that allows the store admin to make notes against products in the product editor. These notes are also made visible to ADMIN (only) in the store front. Useful for making information about a product available to your web and/or sales team regardingY certain products.
Show extended price info to admin	On the product card administrators can view extended price information (margin, cost prices, etc.,).
Product info disclaimer	Text entered here will be shown under the product information. For example, you can display a message like "Specifications & descriptions are accurate at the time of publication, but are subject to change without notice".
Show sharing and bookmarking	You can let your visitors share products using social media by creating an account with http://www.addthis.com and enter the code you get from them in the box "Sharing code", see below.
Sharing code	Code that comes from http://www.addthis.com . Make sure the link is secure (HTTPS) otherwise users may encounter security error messages.
Default tab	This option specifies which of the tabs is open by default when product information is selected, the options available are Information , Specification and Accessories .
Accessories list expanded per default	The product card displays "Accessories" as a separate tab. If you want the list expanded by default, tick this option.
Show free text specification in PDF	Select this to show the specification on an imported products PDF file. Be aware - if the specification contains HTML, it may make the PDF look bad.
Show free text description in PDF	Select this to show the description on an imported products PDF file. Be aware - if the description contains HTML, it may make the PDF look bad.

Show "product ask customer support button"	With this feature enabled, there is a new button for the end customer to use on each product card. When they use it, an email will be generated and sent to admin to respond to.
Highlight product card for search engine	If you want the product card to be indexed and rank higher in search engines, use this feature. This will add product part number in the product title (H1 tags) and include it on the product page URL.

Prices

Setting	What it does
Default inc VAT	Set your shop to show prices including VAT by default.
Show VAT status with price	Set your shop to show "Inc VAT" or "Exc VAT" with the price.
Allow the user to choose if prices are to be shown including or excluding VAT	Enable this to put radio buttons in the mini basket which allow the end user to view prices with or without VAT.
Show a shortened price header in product list	Enable this to just show 'Price £/€' (instead of 'Price GBP Including VAT') in the header of the products list, saving space.
Hide rent prices below break point	If you don't want to show rent prices below a specific price, enter that price here.
Round off prices including VAT	This is a setting that only affects Swedish sites, where it's favourable to round prices to the nearest 10 krona.
In price logic	This sets what cost price (in-price) will be used for sell price calculations; <ul style="list-style-type: none"> • Supplier Priority - Use the cost price from the distributor with the highest priority • Lowest price in stock - Use the cost price from the lowest priced distributor with stock • Average price in stock - Use the average cost price from the distributors who have stock • Average Price - Use the average cost price, whether the distributor has stock or not • Weighted Price in stock - Uses the average prices against the average weighed quantity of different suppliers stock
Display cost price for administrators in the shop	Displays the item cost price in the shop front to admin. This replaces the calculated view they would normally see based on the stores default price list. Please note that it will display the cost price based on the stores cost price strategy.

Stock

Setting	What it does
Show quantity in stock	If this is selected, your shop will show the number of stock available, if not selected, your shop will show coloured images which just dictate whether the product is in stock or not.
Max displayable stock in front-end	Allows the ability to specify what the maximum value to show the value of stock. For example if there is 150 items in stock and you set this value at 100, the store will display "100+" in stock
Estimated delivery date only for the product's current price distributor	Allows you to only show the ETA for the supplier that your store is currently got set for this item instead of multiple ETA's if a product is available from multiple suppliers. The supplier selected for products is based on your stores cost price strategy.
Show incoming stock and ETA dates from suppliers	Allows you to turn on/off the option to show a products ETA.
Separate stock per warehouse	If you have multiple warehouses created in Netailer, selecting this will show stock levels for each discrete warehouse. If not, only one stock level will be shown.
Show internal qty in stock	If this is selected, your imported stock levels to show separately from what is showing from the integrated feed levels.
Strategy for buying out of stock products	Here you specify your strategy for handling the sale of products that are not in stock.
Disable buying of items that are out of stock	If this is selected, the buy button will be greyed out on items with zero stock. The customer will still be able to select the product and see all the product data, but will not be able to add the product to their basket.
Disabled buy button	If the option above is selected, you are able to select the behaviour of the buy button. You may simply have the buy button Dimmed and inactive or have the Notify me function enabled. When the Notify me is selected, when presses will send a notification to admin that you want to be notified when this product is back in stock. If a customer is logged in, the customer's email will be used automatically, otherwise the user is prompted for one.
Incoming stock is in stock	Allows you to set any incoming products as "In stock".

Miscellaneous

Setting	What it does
Show category tree	This only affects shops with left side navigation. Disabling this will remove the category tree.
Hide text for qty check in database	Some distributors do not allow for a real time check of Price & Availability, when attempting to perform a real time check, P&A from these distributors are labelled as being pulled from the database (populated from the last feed update). Enabling this setting will hide the label.
Do not show menus or search field if the customer is not logged in	Selecting this will effectively hide all the products unless the user is logged in.
Show general assortment switch for administrators	Allows administrators to toggle between general and customer connected assortment when logged in as a customer. Note that it does not affect general limitations (product range and product range limitation filters).
Allow export of basket to Excel	Selecting this allows customers to export their basket contents & details to an Excel spreadsheet.
Number of days that new products are hidden	If you do not want to display newly added products in your shop, enter a number here to stop them appearing for a period of time.
Show product forms when item is added	Shows the product form before checkout when a product is added with a product form connected to it. Legacy setting for "Nettailer classic".
Show the retailer specific product information separately	Adds a new text field above all product information tabs, where your own product description will be shown.
Edit product name in basket	Allows store admins to change product names in the basket.
Show focus assortment link on product	This adds an icon and with a clickable link to a "focus assortment" if a product belongs to one.
Show override product range button for administrators	Adds the ability for the store admin to see products that would normally be hidden by store set filters set up in product range limitation tool.

Configurators

Nettailer comes with a number of configurators that you can easily activate through this interface. You also choose here how configurators as a whole should be experienced in the graphical front end, where you can change the title, change the name of the link, upload one picture per configurator, etc.

Feature	What it does
Show configurators	Disable this to hide all configurators & the configurators border.
Header	The title at the very top of all the configurators. E.G. "Product Guides".
Text	The sub-title at the very top of all the configurators. E.G. "Having trouble finding the right product? Try our Product Guides!".
Image	If you'd rather have an image at the very top of all configurators, upload it here.

Example configurator and settings;

Feature	What it does
Show Kingston	Enables the individual configurator.
Link name	Text which will be click-able to get to the individual configurator. E.G. "Memory Finder".
Sort order	Allows you to sort the configurators. Always sorts low to high, so number 10 will be above number 30.
Image	Upload an image for the configurator.
Show link name	If this is disabled the 'Link Name' above will not be shown.

Customers

Customer registration

Feature	What it does
Additional tab for customer registration	Select this to display a tab (in left navigation) or link (in top navigation) labelled "New Customer", this appears next to "Login" which allows new customers to register for an account.
Allow new customer registration	Enable this to allow customers to register for an account. If this is disabled, the administrator must create all customer account manually.
Allow customer administrators to create users	This allows customer admins to create additional users within that customers account. This setting means store admins wont need to approved these new users.
Allow company customers	This allows the customer to register as a company, which makes different information mandatory during registration.

Allow customer to enter a customer group reference on registration	If enabled and a reference name and/or number has been pre set on against a customer group, then the registering customer may enter this reference number and automatically be added to the corresponding customer group on submission
Allow private persons	This enables customers to register as a person, which makes different information mandatory during registration.
Registration in the checkout	This allows customers to register for an account during checkout. If this is disabled, account registration must be carried out before checkout can be completed.
Use email address as user name	Enabling this feature will ask the user for their email address at login instead of a username. You will find this feature useful as most people can remember their email address.
Require current password on password change	if enabled it forces a user to type their current password in, to be able to create a new password.
Activate customers manually	Enabling this will mean that while customers can apply for an account, but won't be able to log in or make purchases until their account is approved by an administrator.
Allow customers to edit their own customer information	Disabling this means that customers cannot edit their contact information or stored addresses, it can only be edited by an administrator.
Allow customer group admin to edit options	Grants the customer group admin some additional control over some of the display options for users they control.
Send mail to customer on registration	Enabling this will allow the system to send an email to the customer on registration. The email will also contain a randomly generated password that must be used the first time the customer logs in.
Send mail to admin on registration	Enable this to send an email to the administrator when new customers register for an account.
Show prices	Enable this to show "Log in to see price" on products if the user isn't logged in.
Show buy button	Gives you various option on when the buy button is available.
Check "Allow partial deliveries (as default setting)" per default	Enable this to set "Allow partial deliveries" as the default on customers accounts. Customers can still override this if they want to.
Check "Please keep me updated on products and services." per default	Enable or disable the default setting for "Please keep me updated on products and services" option on registration. The user can of course change this setting before submitting their registration.
Information for customer registration	Allows you to specify information that appears when new customers register for an account.
Registration link	Add a unique URL for registrations. Adding a URL will automatically activate the setting

Feature	What it does
Number of digits in delivery postcode	Specifies the maximum number of characters that may be put in the "postcode" box.

Invoice handling

Feature	What it does
New customer is registered with setting "Disallow invoice"	Enable this so any new customers registered cannot select "Invoice" as the payment type during checkout. Specific customers can be manually edited to allow invoice by the administrator.
Allow invoice after successful credit card payment	Enable this to allow customers who paid by credit card on their first order are able to choose invoice for future purchases.
Show check-box "Contract customer" at registration (allow invoice)	Enable this to allow existing contract customers to register with this status and automatically gain access to payment by invoice.

Feature	What it does
Empty basket on logout	Enabling this will take the customer to the basket when they click "Buy" on a product. This will also show any related accessories under the basket.

Log in/Log out

Feature	What it does
Empty the cart when logging out	If you want the shopping cart to be emptied as soon as you or your customer log out, you can activate this function here.

Display options

Feature	What it does
Show customer number in the customer info page	Adds the customer number (assigned to a customer in the customer editor in admin) to be visible to the customer on the customer info page. If this is not enabled there is nowhere in the shop front for a customer to identify their account by anything other than company name and the users details.

Promotions

Feature	What it does
Number of promotions to the right of the shop	Specify the maximum number of promotions to show to the right of the shop. If more promotions exist than this number, the shop will randomly select this many (unless "exempt for randomisation" is selected on the promotion).
Number of right side promotions	Specify the maximum number of promotions to show in the right hand column of the shop. If more promotions exist than this number, the shop will randomly select this many (unless "exempt for randomisation" is selected on the promotion).
Number of promotions in midsection	Specify the maximum number of promotions to show in the central column of the shop. If more promotions exist than this number, the shop will randomly select this many (unless "exempt for randomisation" is selected on the promotion).
Show promotions for users that aren't logged in	Disabling this will hide all promotions if the user isn't logged in.

Recently sold



This feature is automated and shows the most recently sold products over the last 2 weeks by default, but this setting can be changed.

Feature	What it does
Show	Disabling this will hide the 'Recently sold' box on the left of your site.
Show recently sold above products	Enable this to show recently sold products above the product list (if no category-specific promotions are available).
Show image	Enable this to show images of the most recently sold products.
Number of items	Set the maximum number of products to show.
Label length	Product names will be truncated to this number of characters, handy for when a long product name looks ugly.

Top sellers



Tip

This feature can be automated to show the products with most sales over the last 3 months by default but this setting can be changed.

Feature	What it does
Show	Disabling this will hide the 'Top Sellers' box on the left of your site.
Generate automatically	Enable this to organically populate the top sellers list. If this is disabled, you will need to specify which products you want to show in "Products" > "Top Sellers".
Number of items	Set the maximum number of products to show.
Number of days back	Allows you to set how far back the system will look back to populate the pre-set number of top sellers need.

Notifications

Feature	What it does
Email notification when promotion disappears from stock	With this enabled, an email is sent to shop admin if a promotion is not in stock.

Menu

Feature	What it does
Show settings menu	Enable this to show a tab (left navigation) or link (top navigation) labelled 'Settings'. This will allow customers to hide the 'Filter' in product lists. Verva customers will also be able to hide all products that aren't Verva specific.
Show promotions menu	Enable this to show any new "Promotion Categories" you create.
Show Returns in menu	Enable this to show the link labelled 'Returns' under 'your account' on the homepage.

Start menu

Feature	What it does
Show start menu	Legacy setting for Netailer "Classic"
Start menu header	Legacy setting for Netailer "Classic"

Defaults

This section specifies some of the global default setting for areas that may have multiple options for various shop settings (default currency for example).

Feature	What it does
Tax	Pick which tax setting to use as default.
Country	Specifies the default country when customers create/modify their address details.
Currency	Specifies the default currency of your site.
Distributor	Specifies the default distributor.
Price list	Specifies the default price list. Any customer not logged in, or set as 'default' will see the prices in this tier.
Delivery option	Specifies the default delivery method.

Miscellaneous

Here you can set a number of general settings that apply to the shop.

Feature	What it does
Logo URL	Specifies the main URL of your shop. This is used in exports (E.G. Google Products) to link back to products information. This will also give a better hit rate in search engines.
Footer	This sets what text is visible in the footer of your site.
Responsive design	Activates the responsive design Framework (RWD is now default in all Netailer shops)
Use responsive design for this session	Activate this setting if you are a Netailer "Classic" customer working on your RWD migration. This allows your session to view the new framework without affecting your live shop.
Show old design link	Allows you to show a link on your store to your previous Netailer "Classic" store. This is usually only used while "Classic" customers are migrating to RWD
Block old design when the responsive one is available	Prevents any previously set up documents from being displayed in the Netailer "Classic" format and instead force them to be displayed on the RWD format.

Security

Feature	What it does
File area key	Only used by Netset admin at this point.

Clickjacking protection enabled.	Clickjacking is a type of attack that tricks users into clicking something, such as a button or link, because they perceive it to be safe. By creating hidden iframes pointing to your site pages, hackers can entice users to click an element that appears to be on a different web page. But instead of the visible element handling the click, the click is hijacked and some element of the invisible site iframe on top receives it. Clickjacking can potentially lead to data intrusion, unauthorized emails, changed credentials, or other malicious site-specific results. With clickjack protection, however, you can secure your site by controlling whether browsers allow frames pointing to your pages.

Checkout

Feature	What it does
Show check box for terms of purchase at checkout	Specifies whether your customer needs to check that they have read the terms of purchase before making purchases in the order process.
Show processing order message	Check this box if you want a notification to appear when your customer clicks "Place an order". This we strongly recommend that you do as this has two main purposes: 1) The customer will not think that the page has hung if it takes a long time and 2) The customer can not click anywhere during the actual transaction which may cause the order to worry be able to arrive.
Show row total in basket	Use this option to display a row total at the checkout page. Useful if you have multiple quantities per line. This also give a true line total for VAT calculation.

Small order charge

Feature	What it does
Use small order charge	Enable or disable the small order charge feature. This will add an additional charge at the check to any order that meets the configuration set below.
Small order charge	This is the charge applied to an order that qualifies as a small order.

The small order charge will appear at the checkout if the breaking point is not met. The breaking point is also displayed to give the customer the opportunity to add an item or two to avoid the small order charge.

Form editor

This section is for you to determine what information you require from your customer to register and place orders. Here you have the ability to specify the fields you want to use in your shop and edit their properties. The fields have been grouped into different tabs depending on the information required: Contact information, Order information, Shipping address, Billing address, and Payment information.

Function	What it does
Sorting	Each tab has a sorting order. The sorting number determines the order in which each section appears on the customer registration and ordering page. The higher the numbers the further down the page the section will appear.
Original Label	This is the default name of a field set as the Nettare standard.
Own Title	This is the name of the field you may enter to replace the original label.
Active	Tick this box if you want this field to be displayed.
Mandatory	If you want a field to be mandatory click here. If selected the registration/order process will not complete until the customer has entered this field.
Sort Order	Determines the order in which the fields are displayed on the form. The higher the number the further down the list the field will be displayed.
Character Count	Min and Max Allows you to specify minimum and maximum number of characters you want the client to use in a field.
Mandatory group	In the case you want one of several values to be mandatory, you can group them here. For example if you want the customer to specify either the "Marks" or "Invoice reference", you can group them by giving them the same value, such as 10. The shop will then notify the customer in the event that he tries to place an order without any of the relevant fields completed.
Do not use the default value	Nettare automatically sets values for some of the fields. In the event that you do not wish Nettare to use the default values for a field, click the "Do not use the default value".
Read Only	This makes the field read only and un-editable by the customer at checkout.

Graphical profile (none RWD)

Please Note



This editor refers only to graphic profile in classic design.

The graphical profile is a powerful tool that allows you to easily change the whole presentation of the store by following the images and prompts. Netailer supplies you with a basic graphics template as standard so you can edit and adapt the style to suit your own company's branding.

The graphical profile has been designed so that content can be added or edited without any special knowledge of programming software or html. We have provided you with drop down boxes, areas to browse and upload your own icons, buttons, images and much more to allow you to make your own choices.

It is written in a way that any changes made will not affect compatibility when new updates are applied to the Netailer platform.

Using the Graphical Profile

Once you have entered the graphical profile feature, you will be able to create new versions of the graphical profile for your store or edit old ones. It's easy to switch from one profile to another which can be useful if you want to have seasonal or major holiday themes. You are able to rename, edit, delete and copy versions at any time.

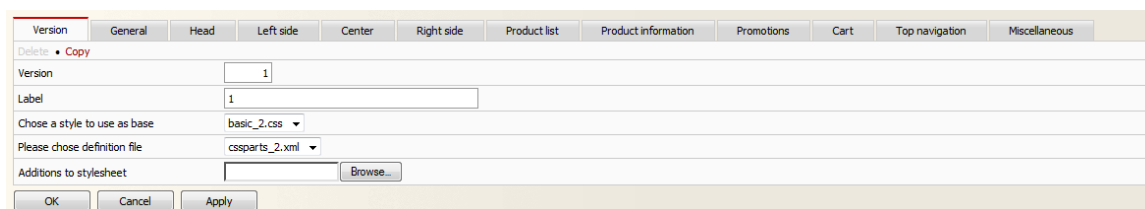

Profiles



The graphic profiling tool breaks down each part of the site into different tabs to help you get to the area of the site you want to change. Each section has image examples with a number system allocated to them and each setting is then numbered to correspond with that image example.

This will help you work out what settings change which section of the site, almost a “paint by numbers” experience. Next invoice number

Here you set what the next invoice number should be in the shop. This value is normally only in the start up of the shop or at the end. You can set what the next or start invoice will be in the store. This setting is usually used as a onetime set up, but can be amended at any time.

Next order number

This feature is usually a onetime set up, it allows you to enter the starting order number in the store once you are ready to go live, giving you the flexibility to start where your last store or your manual process ended.

Notifications

Currently only used for "Ask product question" feature on the product page.

When various mail forms are being used, you can use this feature to send out a confirmation mail, to reassure that the end-user that their request is being dealt with and give a written confirmation of the actual request.

Order status

In this section you find the different order status available in the shop. Here you can also change their names and create your own if you wish.

If you create your own order statuses and want to communicate these, you must create an email template for this.

Order confirmation editor

In this section you will find the settings for order confirmations sent from your store. Using the free text boxes, you can add titles, your contact information, customise labels, colors, fonts, and logo.

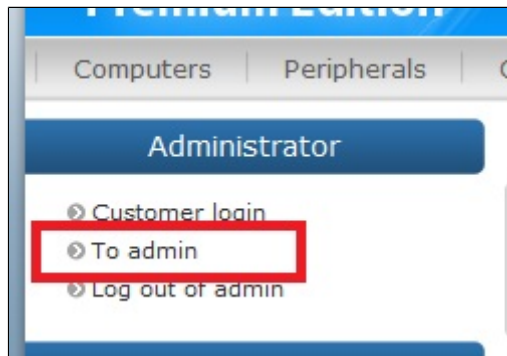
Log in as customer

This facility allows the administrator to login as a customer. This offers you the facility to see what your customer sees, with a few administrator additions.

The log in as customer feature allows you to see what the customers see, quote them on their agreed pricing and assist them with orders. The advantage to using this facility is that you have the power to over ride already agreed pricing, quotes or assist the customer in general

To utilise this feature from the admin section you must first of all be logged into admin and then click on "Log in as customer" now select the customer in question and complete as required.

From the admin section you click "go to shop" to move from the back end to the store. To go back to the back end area you click on "To Admin" from the administrator panel as shown below.



A great feature of login and viewing the shop as administrator is, on each of the product pages you can clearly see the product information that is otherwise hidden. You will see the cost price and check stock from your list of suppliers.

You may also login as a customer with your administrator credentials. Click on the "Log in as customer link". Here you are shown the list of customers that are attached to your store, you can search for a specific customer using the search tools at the bottom of the page. Fill in the relevant field and click "filter" then select the customer by clicking on them from the list. You are now logged in as both administrator and customers. The prices now shown are those for the selected customer. Now you are able to do everything your customer can, including place orders and view products. This is useful if for example a customer calls and wants to place an order. You may just do it on their behalf with the greatest of ease. In the role you can also see extended price information. This shows the purchase price, current price list, margin and contribution margin ratio.

By clicking the "Logout" in the login box you will log out as a customer, but you will still be logged on as an administrator and may for example, log in as another customer in the event that you want to add more orders on behalf of clients.

In the event that you as an administrator want to manage roles and permissions within a customer group then it is recommended you log in as the user responsible for the customer group.

Once you have selected from the list which feeds you want to use on your site and have set up your accounts, we will request the feeds on your behalf. We require the following information to carry out this process and submit our documentation to each distributor on your behalf.

1. Supplier names
2. A confirmation email instructing us to request the feed on your behalf along with you (Account Number).
3. Your account managers name and contact details (if you have them, this makes the whole gathering feed process faster)

Any accounts that you have very recently set up may take an extra week or so to provide. This is due to the distributors internal process of account managers setting up the details on the system for IT departments to be able to produce a feed.
